

**Barrier Technology Incorporated (Barrier)** warrants to the **applicator** of Mycoguard Mold and Mildew Resistant Coating (Mycoguard) that, for the twenty-five year Limited Warranty period from the application date, Mycoguard will resist active visible surface mold growth under normal operating building conditions when applied to a clean exposed surface in strict accordance with the material preparation and application guide located on the Mycoguard Product Application Guide and the additional requirements of this Warranty. A current copy of the Product Application Guide may be obtained from Barrier via the website, [www.intlbarrier.com](http://www.intlbarrier.com), under Products, Field Applied Products or at the address listed below.

If Barrier determines, upon review or investigation, that specific Mycoguard failed to perform in accordance with this Limited Warranty, Barrier will:

- refund the purchase price of the Mycoguard used for the application in question, or the relevant portion thereof; and
- provide reimbursement for the cost of the labor associated with the application of the Mycoguard in question, or the relevant portion thereof, as reasonably determined or estimated by Barrier.
- The remedies stated in this Limited Warranty are exclusive.

This Limited Warranty is in place of all other warranties, express or implied. **Barrier expressly disclaims any other warranties to the applicator, including implied warranties of merchantability and fitness for a particular purpose.** It is the sole responsibility of the applicator to determine the suitability of Mycoguard for the intended application. The applicator assumes all risk and liability whatsoever regarding such suitability. **Barrier also disclaims all warranties to the building owner or any other party related to the purchase and use of Mycoguard, including implied warranties of merchantability and fitness for a particular purpose.**

**Qualification.** For this Limited Warranty to go into effect, all of the following requirements must be met:

1. The substrate for application must be free of all dirt, debris, mold or other materials that will impede bonding of Mycoguard to the substrate surface.
2. Mycoguard must be applied to the **entire surface at 500 ft<sup>2</sup>/gallon.**
3. Mycoguard must be **applied by a contractor pre-approved by Barrier and** in strict accordance with the Product Application Guide.
4. Applicator **must register the project with Barrier** using the attached form and retain records of amount of product used, product cost, and application labor costs.

**Exclusions From Warranty Coverage.** This Limited Warranty does not cover, and Barrier will have no liability for any damage or failure of Mycoguard caused by, or due to, any of the following:

- **Use of Mycoguard that is applied one year after purchase date.**
- Surface alterations, including painting, on the finished Mycoguard surfaces.
- Mold growth on accumulated material or debris on the Mycoguard surface.
- Removal, replacement and/or reparations to the surfaces treated with Mycoguard made prior to notifying Barrier of any claim.

**Warranty Service.** Applications for performance by Barrier under this Limited Warranty must be made to Barrier in writing, as set forth below, within 60 days of the discovery of the alleged failure of Mycoguard to perform in accordance with this Limited Warranty. Applicator will arrange to provide Barrier with a reasonable opportunity to review and investigate the alleged deficient performance. Applicator will retain records of product and application costs and provide a copy of this Limited Warranty to Barrier when making a claim hereunder.

**Limitation on Liability.** In no event shall Barrier have any liability beyond refund and reimbursement, as set forth above, and in no event shall Barrier be liable for any special, direct, indirect, incidental, consequential, exemplary, or punitive damages (including, but not limited to, lost profits, lost sales, injury to person or property or any other damages) arising out of the sale or use of Mycoguard or for any use or misuse of Mycoguard, regardless of the legal theory claimed, whether in contract, tort or otherwise.

**Choice of Law.** Barrier's Limited Warranty shall be governed and construed under Minnesota law, without giving effect to any principles of conflicts of law. Any claim under or related to this Limited Warranty, whether in contract or tort or for breach of warranty, shall be governed by Minnesota law, without giving effect to any principles of conflicts of law.

**Notification of Claim.** The Applicator must notify Barrier in writing at
